- Outstanding Registrations
 - o Board Members will contact assigned families about registrations.
- QAS EANS Funding Allocation
 - The Emergency Assistance to Nonpublic Schools are federal funds that are being made available to all nonpublic schools to address past expenses and future costs associated with the impact of the Covid-19 pandemic.
 - The potential allocation of EANS funds to QAS is \$273,250.00. This amount could increase
 or decrease to some degree. This allocation is based on the total enrollment we submitted to
 DESE in October of 2019 plus consideration of our deprivation counts at that time.
 - Fund may be used for **Reimbursement** which includes any expenses we incurred since March 2020 associated with the pandemic for which we did not use federal funds such as CARES Act funds or Title funds and for which we as a school obligate by August 31, 2021 for spending in the next two years related to the pandemic.
 - Funds may also be used for **Procurement** resources and services which we need to address student performances and provide virtual instruction as needed going forward.
 - A plan must be developed and submitted to DESE no later than Friday, April 30th. Plan should focus on the following three areas: Health & Safety, Learning Loss, & Virtual Learning.
 - o **Proposed Plan** for EANS Funding:
 - ➤ Technology: enabling QAS to be 1:1 technology. K-2:iPads & 3-8: Chromebooks. As well as sync carts, routers, charging carts, No Red Ink license, etc.
 - ➤ Virtual Learning: online resources for virtual learning, subscriptions.
 - Learning Loss: Support services for learning loss. Math Interventionist, Virtual Learning Consultant, and Summer Bridge Activities. Personal positions have to be contracted out(consulting).
 - o Bethany(new principal) is on board with all the decisions to use the funds.
